# Hooligan River Run

## Information & Rules

### Crafts Allowed – No kayaks, SUPs, boats allowed

- Inner Tubes
- Inflatable Rafts
- Floatables hand-made from cardboard, other river friendly materials

### Race Rules – Teams are required to have 2-5 members

- Safety First- All riders MUST wear a Personal Floatation Device.
- Water shoes recommended.
- No intentional splashing your competition or attempting to impede others in any way. Incidental contact and splashing may occur, however, you will be disqualified if these actions are intentional. Unsafe or detrimental behavior will also be grounds for disqualification.
- Inner tube teams must run the course as one unit, by linking arms, legs, etc; No ropes or other methods of connecting tubes together.
- Rafts and Cardboard crafts will run as individual units.
- No batteries, generators, fuel, or hazardous materials allowed.
- Crafts (including any pieces that come loose/fall off) must be completely removed from the river/riverfront area upon completion of race.

### Timing – Brantingham Bridge is Finish Line; exit at Boat Ramp

- Each team will run the course one time.
- Groups that do not cross the finish line with at least one rider on a craft will be disqualified.
- Winners determined based on fastest times – Judges' decisions are final.

### Awards

- 1<sup>st</sup>, 2<sup>nd</sup> Place – Based on fastest times.
- Paddlers' Pick – Given to the most original entry, as determined by panel of paddlers.

## Schedule\*

### **Registration: Pre-Registration or On-Site until 12:00 PM**

On site registrations will be accepted until 12:00 PM on day of event.

Pre-registrants must check in for team numbers and race order prior to 12:00 PM.

### **Line Up: approximately 12:15 PM – listen for announcement**

All teams must be on site and ready for line up by 12:15 PM.

Line up will take place on the sidewalk on the North side of the river – behind City Hall / Hot Shots.

### **Race: approximately 12:30 PM – listen for announcement**

Teams will enter river just above first whitewater feature and race through entire course with finish at Brantingham Bridge.

- *When finished with race, please exit river at boat ramp.*
- *You must remove your craft completely from the river and riverfront area – no leaving parts of any kind.*

### **Awards: Following the Race**

When races are over, please join us for the announcement of awards at the band shell. Prizes will be given out to the winners!
